

MINUTES OF NORTON BOARD OF HEALTH MEETING
January 10, 2011

The Norton Board of Health held a regular meeting on Monday, January 10, 2011 at 6:30 PM in the 1st Floor Conference Room of Town Hall. The following members were present: Chairman Steven H. Corr, PE, Vice-Chairman Robert B. Medeiros, Clerk Diane Battistello, Health Agent Leon J. Dumont, and Administrative Secretary Cynthia J. Peters.

Call to order

Chairman Corr called the January 10, 2011 Board of Health meeting to order at 6:34 PM.

53 Freeman Street - Requesting a variance from the Norton Board of Health, Rules and Regulations 5.7, which requires a 25 foot setback from the property line allowing the proposed non-potable well 19 feet from the property line.

Mr. McCarthy, the homeowner was present with proposed non-potable well location plans from Yarworth Engineering. No property abutters were present.

After a brief discussion the following motion was made.

Vice-Chairman Medeiros made the motion to grant 53 Freeman Street a variance allowing the non-potable well a reduction to 19 feet from the property line instead of the require 25 foot. Clerk Battistello seconded this motion. This motion passed 3-0 M. S. D. V.
