Old Business

- **417 Old Colony Road**

Vice-Chairman Medeiros made the motion to move this item to the end of the agenda. Clerk Battistello seconded this motion. This motion passed 3-0 M. S. D. V.

- **Perceptions Hair Salon**

The Board reviewed the testing results analyzed by Analytical Balance which, were completed on December 22, 2010. The septic tank Fecal Coliform results MPN versus only 2,300 MPN from the previous sampling event. These results seem to indicate that there is less discharge of chemicals into the tank that can reduce biological activity. The volatile organic testing also showed significant reduction in possible hair bleaching or coloring chemicals versus the previous sampling event.

Chairman Corr stated that Perceptions Hair Salon seems to be doing a pretty good job and the testing results look reasonably good, suggesting that another random test be done in six months.

Vice-Chairman Medeiros made the motion that Perceptions Hair Salon completes another random test in six months. Clerk Battistello seconded this motion. This motion passed 3-0 M. S. D. V.

- **246 East Main Street**

Ms. Peters stated that the Board of Health received testing data for the FAST Wastewater Treatment System at 246 East Main Street.

Chairman Corr reviewed the Field Inspection & Service report dated 12/19/2010 to the test taken 8/31/2010. The BOD increased to 62.8 mg/L in most recent sample from December 20.2 mg/L from the August test indicated potential reduced treatment. Total Kjeldahl Nitrogen was 27.3 mg/L from the December test versus 19.1 mg/L from the August test. Nitrate Nitrogen was <0.50

mg/L from both the December test and August. pH was 7.3 in December test and 7.2 in August. Total Solids Suspended increased to 27 mg/L in December versus 15.5 mg/L in August. Chairman Corr requested retest in 3 months due to the rise in BOD in the effluent

- **Arrowhead Village**

Ms. Peters stated that the Board of Health received the quarterly monitoring report for Arrowhead Village treatment plant located on Arrowhead Drive.

Chairman Corr reviewed the inspection report stating that Arrowhead has meet all parameters for the quarterly report inspected on 12/15/2010 and appears to be functioning normally.
