MINUTES OF BOARD OF HEALTH MEETING

March 3, 2014
Regular Meeting

The Norton Board of Health held a regular meeting on Monday, March 3, 2014, at 6:30 PM in the 2nd Floor Board of Health office. The following members were present: Chairman Steve Corr, Vice-Chairman Robert B. Medeiros, Clerk Diane Battistello and Health Agent Leon J. Dumont. Visitor: James Prosser, General Contractor

Call to order: Chairman Corr called the meeting to order at 6:31

377 Old Colony Road:

James Prosser, the general contractor for the replacement septic system for Old Colony Nursing Home attended the meeting to discuss the septic repair plans. The cold weather will hold up the land clearing process. The target date is the beginning of April. It is estimated to be a 9-week installation process. There needs to be an additional electrical pole installed to run the systems pumps. Agent Dumont will require testing in sections. Chairman Corr will require certification of the Title 5 sand that is being used. The main tanks capacity is 26000 and 10000 pump chamber. Agent's Dumont expects a minimum 2 inspections per week: bottom of tank, stone (1 ½" rather than ¾"). Chairman Corr questioned the availability of double washed stone this time of year. Gallons a day: 7720. Discussion ensued regarding system alternatives (i.e. Cultec chambers). Mr. Prosser and Mr. Dumont will contact RIM Engineer regarding this.
