The meeting was called to order at: 6:31 p.m.

Minutes from the June 2, 2014. Meeting were reviewed and Approved with No adjustments.

Meeting Motions / Actions and Summary of Discussions:

Visitors: Simon Paff,

Simon Paff – 205/207 South Worcester Street, Shared Septic System Issue

The existing house, #207 has a three bedroom septic system. The approved septic system plan for the dwelling indicates two bedrooms and a sewing shop. The lot, subsequent to the approved plan, was subdivided and Mr. Paff originally stated he wanted to build a new dwelling, #205 on the new lot and tie into the existing three bedroom septic system creating a shared system for the two lots. Since the new house was pro[posed for two bedrooms the Board would require a deed restriction for #207 limiting the existing house to one bedroom and a deed restriction on #205 limiting the new house to two bedrooms.

Mr. Paff approached the Board with an idea of installing a new septic system on #205 so that each property would have three bedroom septic systems. He also brought plans that were approved by the previous Board, on 4-02-2008. Mr. Corr noted that Title 5 stipulates that approvals are good for three years and can be renewed for an additional year only if the owner requests an extension from the Board. Mr. Paff did not request an extension. Mr. Paff would therefore need to reapply to the Board for approval. The Board could not at this time agree with the previous approval. The Board was in agreement that the new lot for #205 probably was not large enough to install a fully complying Title 5 system for the new dwelling. The Board encouraged Mr. Paff to investigate the possibility of obtaining an easement on an adjacent lot.
