New Business: The Health Department has received complaints about 94 Plain St, owned by Mr. Stuart Graf. In 2013, the Norton Fire Department found hazardous material on the property now he has approx 7 boxes trailers, 6 cars, piles of wood and pipe. This property is zoned residential. An inspection was done by Health Agent Zahner on 1/7/16. He spoke with Mr. Graf and Mr. Graf said he will start to clean up the site. Agent Zahner went on 1/11/16, and there was a dumpster on site and some progress. Health Agent Zahner will continue to monitor the cleaning process weekly.

Health Agent Zahner spoke to the Board regarding, Norton Mobile Homes Estates, 157 Mansfield Ave. Mr. John Sullivan, Administrator has not turned in his application for 2016 and after several conversations during 2015, he still has not turned in his Community Rules. Septic Plan Review: George Collins of Collins Engineering Group is requesting a variance on behalf of 130 Mansfield Ave, Norton, MA. Mr. Collins is requesting the Board consider allowing the design flow to be based on water meter readings for a septic system less than 10,000 gallons per day. He is proposing to use average daily water reading during last 4 years, as a design base. Mr. Corr stated that Title 5 is based on peak daily flow not average flow. Mr. Collins provided quarterly flows which do not address the issue. After discussion, Mr. Collins said he was going back to his client to see if there is another way to redesign the system. Chairman Medeiros recommended tabling this discussion until our next meeting.

Open session for issues not anticipated 48 hours in advance: 189 Taunton Ave, Norton, MA, Agent Zahner received an anonymous call over the weekend regarding a septic repair done without applying for permits, or using a licensed installer. Agent Zahner suggests that homeowner needs to have a Title 5 Inspection. He will issue the enforcement letter to homeowner.
