Call to order: Ms. Battistello called the meeting to order at 6:30 PM.

Consent Agenda: Mr. Medeiros made motion to move Old Business # 4, up on Agenda before New Business, Ms Battistello seconded. Vote: 2-0, Approved

Old Business: Marilyn Edge reviewed the tobacco regulation changes and after discussion, Mr. Medeiros made a motion to accept the new Chapter 15, Town of Norton Regulations on the sale of tobacco products effective immediately. Ms. Battistello seconded. Vote: 2-0, Approved

Mr. John Sullivan of Norton Mobile Estates dropped off a corrected copy of rules and regulations for Norton Mobile Estates and the certified mail receipt showing they were sent to Attorney General's Office on Friday 7/29/16. Attorney General office will notify us of their findings.

New Business

Rajankumar B. Parmar has submitted an application to open a smoke shop at 130 Mansfield Ave. Marilyn Edge, Tobacco Agent, began discussion asking what the smoke shop would be selling, and the Chief of Police said there is some paraphernalia that is not legal to sell in Massachusetts. The Chief is putting together a list of items that cannot be sold in Massachusetts. Mr. Parmar is also asking permission to smoke inside, because it is not a free standing building, it is not legal to smoke inside a public building in Massachusetts. After discussion, the Board agreed to let Mr. Parmar open on a conditional one month trial, as long as they obtain a business certificate from the Town of Norton as well as approval from the Inspections Department. Mr. Medeiros made motion to open the Adult Only Tobacco Store with restrictions for one month. Vote: 2-0 Approved
