Call to order: Mr. Corr called the meeting to order at 6:00 PM.

Acceptance of Minutes: Mr. Medeiros made a motion that the minutes from November 7, 2016 be accepted. Ms Battistello seconded.

32 North Worcester St, Yard Cleanup: Mr. & Mrs. Bachand were invited to meeting because of complaints from local neighbors, regarding condition of property which includes unregistered cars, car parts and other types of metals, possibly gasoline and oil in ground, as well as sanitary issues. The property is a residential lot and Norton zoning by laws do not allow more than one unregistered car on the property. Health Agent Zahner requested a meeting to develop a reasonable schedule for cleaning up the property. Mrs. Bachand, said cleanup has begun, but certain health circumstances had slowed the cleanup. Chairman Corr indicated that the Bachand's should meet with the Health Agent to develop a cleanup schedule.

After discussion, Vice Chairman, Ms Battistello, made a motion that the Bachand's, meet with Health Agent, Christian Zahner, to develop a plan to clean up the site with a reasonable end date and allow the Health Agent, Building Inspector and Deputy Fire Chief, with the Bachand's permission, to tour the property.
