Chris Zahner, Health Agent went out to property, saw sewage waste on ground. Also, there were pictures taken by complainant. The Health Agent contacted Mr. Bruzzese and met him on property. Opened cover with Mr. Bruzzese's approval and tank was under the invert. A few days later, Mr Bruzzese said he had a septic company out and at that time the tank was at operating level. The Health Agent felt there was a backup because filter was clogged and Mr. Bruzzese tried to fix it. Mr. Zahner sent correction orders for the area to be cleaned of contaminated material and was fined \$200. After discussion, Mr. Zahner said that the Restaurant should get on a quarterly maintenance schedule with a license septic company. Mr. Bruzzese will be using Bay State Sewage Disposal. Property was clean and fine was paid.

Marilyn Edge, Bristol County Tobacco Agent is up for re-appointment July 2018-June 2022, contract needs to be signed to approve her re-appointment. The Board decided to renew the contract.
