

Call to order: Ms Battistello called the meeting to order at 6:00 PM.

New Business:

The Board reviewed the monthly report for April for the Health Agent The Board reviewed the monthly report for April for the Assistant Health Agent The Board reviewed the monthly report for March & April for the Public Health Nurse The Board reviewed the monthly report for April for the Animal Control

Mr. Medeiros, made the motion to vote on the yearly reorganization of the Board. Mr. Hebard seconded Vote 3-0 Approved.

Effective 7/1/18, Mr. Medeiros will be Chairman, Mr. Hebard, Vice Chairman and Ms. Battistello will be Clerk

Old Business:

Tobacco 21: Attorney Sbarra drafted the new Tobacco Regulations for the Town of Norton. The Board discussed the changes to the existing tobacco regulations as written by Ms Sbarra. A Public hearing was held on 5/7/18 for input only. The board took into consideration all comments and decided to vote on the new regulations. After discussion, Ms. Battistello made a motion that: The Town of Norton restricts the sale of Tobacco Products to the minimum age of 21, also changes the cap on the number of tobacco licenses issued in the Town of Norton from 19 stores to 21 and restricts the sale of tobacco flavored products to adult only stores. Prohibits the sale of single cigars that are priced at \$2.50 or less and all tobacco sales are prohibited in pharmacies.

Mr Hebard seconded motion Vote 3-0 Approved

Ms Battistello made a motion that the new rules & regulations regarding tobacco, tobacco flavoring products, cigars and number of tobacco licenses allow in the Town of Norton goes into effect September 1, 2018 Mr Hebard seconded motion Vote 3-0 Approved

Ms Battistello made a motion to approve the Western Bristol County & Foxborough Tobacco & Alcohol Prevention Collaborative receipt to be given to all vendors who sell Tobacco and Tobacco Flavored products, acknowledging the regulations of the Norton Board of Health restricting the sale of tobacco products effective September 1, 2018. Mr Hebard seconded motion Vote 3-0 Approved

New England Ice cream did not show, as requested, to the meeting. Ms Battistello was told by a homeowner, who lives close to the building, that the noise is better but they feel vibration in their mobile home from trucks & equipment running. They are concerned that after period of time, there will be damage to homes. The Health Agent said that New England Ice Cream did everything and more than the planning department required. They are currently looking into expanding they will be going through the planning board and all abutters will be notified.

Derryth L. Bachand of 32 S Worcester St., gave an update on the progress of cleaning of her property. The board found that there was great progress. Ms Bachand spoke of her plan and timeline of continuing the cleanup and will return to the July 9, 2018 meeting with another update.
