Mr. Giblin suggested possibly Bishop Feehan could help, and he could contact them as soon as possible.

Mr. Kimball told Mr. Brault the Board will work on that issue. It would be helpful for newspapers to also advertise this. Mr. Kimball said he was disappointed to hear this also. This gives them a timeframe of about three weeks until Veterans' Day, so if anyone/residents or public can help, it would be appreciated.

A. **NEW BUSINESS**

1. 7:05 P.M. – Mark E. Burgess Re: Interview for appointment to the Water Bodies Committee

Mr. Burgess said he has fished and boated all his life from here to California, Mexico, to Canada. He has lived in Norton from the early 1980's. He thought he could be a valuable asset to the Board with his experience.

Mr. Kimball said he knew Mr. Burgess personally and is aware he has been involved with water bodies. There is some money in fund to start process. It is important for the Water Bodies Committee to stay focused on all four bodies of water; not a good idea to separate one water body. This Board has recognized the Town has a serious weed problem in all the water bodies.

Mr. Giblin said it is possible more funding will be provided if all water bodies are worked with and not just certain ones in Town. Discussion on freezing weeds method, etc.

It was noted, for record, there were two positions open.

MOTION was made by Mr. Bramwell to appoint Mark E. Burgess to the Water Bodies Committee. Second by Mr. Giblin. Vote: Unanimous. MOTION CARRIES.

2. <u>7:15 P.M.</u> – Discussion Re: Appraisal – Town of Norton/Henderson – (A portion of Map 03/Lot 707) abutting the residence at 25 South Lakeview Road, Norton, MA 02766). Vote to Lease or Sell the Land.

Mr. Peter Clark, an attorney with a law office in Mansfield was present, representing Mr. and Mrs. Henderson. He said his clients have been proceeding with a plan which was first discussed with the Board close to a year ago and Mr. Henderson's health is declining and referenced a handicap addition. Engineering work and architectural work was completed, and they received an order of conditions from Conservation Commission, and appeared before ZBA with a Section 6 finding. Plan to be done next week. Attorney Clark referenced a 1600 square foot easement of their land that Town took by tax taking in mid- 1980's; it was the former Norton Grove Association Club House Property. Lot 707 Town owns; 702 and 703 his client owns and Board had suggested an appraisal be done and it was done by Mark Preston, an appraiser in town. Attorney Clark was here to see how the Board would like to proceed.

Mr. Kimball explained situation and said the present driveway has to cross the Town land. Mr. Kimball referenced 1670 square feet; an additional 15 feet of space basically.

Attorney Clark said his clients have 12 feet of frontage.

Mr. Kimball said they can allow easement or they can sell it.

It was noted addition is to be handicap accessible (wheel-in shower; doorways need to be widened, etc.).

Mr. Yunits said purpose of appraisal was under 30b, anything to be sold or leased; this doesn't meet that threshold.

Mr. Giblin said, in his own opinion, he would probably sell this property.

Attorney Clark said his client will pay for Town Counsel fees, and Town will net about \$2,000.

Mr. Kimball believed it was in the Town's best interest to sell also.

Mr. Bramwell referenced easement to Town.

Attorney Clark explained Town will convey this piece to the Henderson's and it is part of the plan.

Mr. Bramwell responded he had no objections as long as appraisal fair, etc.

MOTION was made by Mr. Bramwell to authorize Town Manager to complete paperwork to sell portion of Map 03/Lot 707 for sum of \$2,000, abutting the residence at 25 South Lakeview Road, Norton, MA 02766, with understanding that easement will stay in place and all costs associated with this will be paid by buyer. Second by Mr. Giblin. Vote: Unanimous. MOTION CARRIES.

3. <u>Discussion Re: Pouring Permits</u>

Mr. Yunits referenced documents related to Pouring Permits and the most common questions of ABCC. Liquor stores can have tastings and they are able to do so; and referenced document Board had in their packets. It does state it is limited to a two ounce portion of malt that can be served.

Mr. Kimball noted no more than two ounces dispensed at one time. Discussion ensued.
