CALCULATING WETLAND PERMIT FEES

Effective October 8, 2004, the following filing fees shall apply.

Category 1 (fee for each activity is \$110.00)

- a. work on a single family lot: addition, pool etc.
- b. site work without a house
- c. control vegetation
- d. resource improvement
- e. work on septic system separate from a house
- f. monitoring well activities minus a roadway
- g. new agricultural or aquacultural projects

Category 2 (fee for each activity is \$500.00)

- a. construction of a single family house
- b. parking lot
- c. beach nourishment
- d. electric generating facility activities
- e. inland limited project minus road crossings and agriculture
- f. each crossing for driveway to single family house
- g. each point source discharge (storm drain)
- h. control vegetation in development
- i. water level variation
- j. any other activity not in category 1, 3, 4, 5 or 6
- k. water supply exploration

Category 3 (fee for each activity is \$1050.00)

- a. site preparation (for development) beyond NOI scope
- b. each building (for development) including site
- c. road construction not crossing or driveway
- d. hazardous cleanup

e. water supply development

Category 4 (fee for each activity is \$1450.00)

- a. each crossing for development or commercial road
- b. dam, sluiceway, tidegate (safety) work
- c. landfills operation/closure
- d. sand & gravel operation
- e. railroad line construction
- f. bridge
- g. hazardous waste alterations to resource area
- h. dredging
- i. package treatment plant & discharge
- j. airport tree clearing
- k. oil and/or hazardous material release response actions

Category 5 (fee is \$4.00 per linear foot)

a. work on docks, piers, revetments, dikes, etc. (coastal or inland)

Category 6 (fee is \$2.00 per linear foot) Boundary delineation for each resource area, does not exceed \$200.00 for single family home or \$2,000.00 for all other activities.

NOTE: Add 50% of the fee for each activity within the riverfront area and another resource area or the buffer zone.

Town Share = $(Total fee \div 2) + \$12.50$

State Share = (Total fee \div 2) - \$12.50
