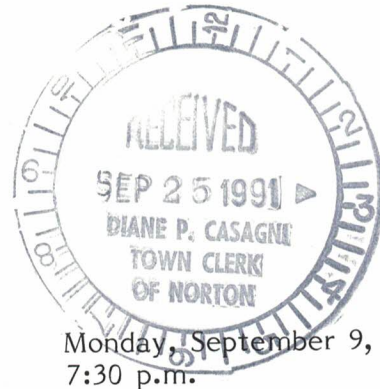

Minutes

Members reviewed the Bill Payment Sheet. Leo Yelle made a motion, seconded by Jeff Houde, to approve payment of the bills as presented. Approved.

Jeff Houde made a motion, seconded by Leonard Silvia, to approve starting the payment process for BayState Environmental Consultants but to hold the check until the third update report has been submitted to, and reviewed by, the Commission. Approved.

Leo Yelle made a motion, seconded by Jeff Houde, to approve the minutes for August 12, 1991, as presented. Approved.

Leonard Silvia made a motion, seconded by Jeff Houde, to approve the minutes of August 26, 1991, as presented. Approved.

Members reviewed a request for a Certificate of Compliance for the Beverly Lane project, #250-166. Leonard Silvia made a motion, seconded by Jeff Houde, to issue a Certificate of Compliance to South Washington Street Realty Trust. Approved.

Robert Medeiros removed himself from the meeting.

The Conservation Director recommended that requests for Certificates of Compliance for lot 19, Margaret Drive and lot 48, Fordham Drive be put on hold until P & A Construction has achieved final vegetative stabilization at these lots. There is a small area of erosion on each lot.

The Conservation Director passed out the proposed restoration plan for lot 103, Margaret Drive, which had been submitted by W & G/Todd Dev. Members will review said plan prior to the next meeting.

Robert Medeiros rejoined the meeting.

The Conservation Director handed out the draft Conservation Restriction for Barrowsville Pond Estates for the members to review prior to the next meeting.

The Conservation Director reported that the Town Manager is asking for voluntary reductions in departmental expense accounts. The members agreed to volunteer a 5% reduction.

The Conservation Director reported that she is working on the Notice of Intent application which will propose the selective cutting and removal of aquatic vegetation from an 800 ft. stretch of shoreline at Norton Reservoir (off Freeman Street).

The members agreed to hold off any discussion of the weed harvester rental bid package until the next meeting.

The Conservation Director read enforcement letters which had been sent to:

The members asked the Conservation Director to ask W & G Dev. to be more specific about when they will construct their wetland replication area at lot 18 (the time frame had been stated, in a letter dated March 22, 1991), as "this year".

The members reviewed a request for a partial Certificate of Compliance for lot 40, Danielle Street. Leo Yelle made a motion, seconded by Leonard Silvia, to issue a partial Certificate of Compliance for lot 40 under #250-169. Robert Medeiros and Jeff Houde abstained. Approved.
