





MINUTES

Members approved the payment of bills.

Members opened the Public Hearing for lot 16, Straw Stone Lane, and continued it, at the request of the applicant's representative, until Monday, August 24, 1992 at 8:15 p.m.

Members continued the public review of lot 68, Hadley Road, at the request of the applicant, until Monday, August 24, 1992 at 8:05 p.m. Bob Medeiros and Jeff Houde abstained from the discussion.

Members reviewed a request from Anthony Defilippo for a partial Certificate of Compliance for lot 2, Susan Circle (Det. #116). Earl Willcott made a motion, seconded by Leo Yelle, to issue said document after a \$1,200 bond is posted with the Norton Town Treasurer to ensure final vegetative stabilization (seeding) of exposed soils within the 100 ft. Buffer Zone on this lot. Jeff Houde abstained from voting. Approved.

Members reviewed a request from Sher-Corp., Ltd. for a partial Certificate of Compliance for lot 4-E, Crane Street (Det. #166). Jeff Houde made a motion, seconded by Leo Yelle, to issue said document after a \$1,000 bond is posted with the Norton Town Treasurer to ensure final vegetative stabilization (seeding) of exposed soils within the 100 ft. Buffer Zone on this lot. Earl Willcott abstained from voting. Approved.

Members reviewed a request from Tim West for a Certificate of Compliance for parcel 60, Plain Street (Det. #182). All soils have been stabilized on this lot. Jeff Houde made a motion, seconded by Earl Willcott, to issue said document. Approved.

Members reviewed a request from Folkman Builders for a partial Certificate of Compliance for lot 14, Straw Stone Lane, noting that construction activities on that lot are not regulable under Order of Conditions #250-210. Bob Medeiros made a motion, seconded by Earl Willcott, to issue said document. Approved.

Members reviewed a request from P & A Construction for a Certificate of Compliance for lot 52, Margaret Drive (Det. #216). All soils have been stabilized on this lot. Earl Willcott made a motion, seconded by Leo Yelle, to issue said document. Jeff Houde and Bob Medeiros abstained from voting. Approved.

Members reviewed a request from Geraldine Carreiro for a Certificate of Compliance for 28 Arrow Road (#250-234). The wetlands violation from 1989 has been resolved. Leo Yelle made a motion, seconded by Jeff Houde, to issue said document. Approved.

Members reviewed a request from the Town of Norton Water/Sewer Dept. for a Certificate of Compliance for the sewer installation around Norton Grove (#250-248). The outstanding issue, an erosion problem at an intermittent stream on Sylvan Road, has been resolved. Jeff Houde made a motion, seconded by Earl Willcott, to issue said document. Approved.

Members reviewed a request from Norman Champagne for a Certificate of Compliance for 269 South Worcester Street (#250-294). The regulable work has been completed at this site. Leo Yelle made a motion, seconded by Jeff Houde, to issue said document. Earl Willcott abstained. Approved.
