A letter from the Conservation Commission to **Mr. Larry Enos** re: wetland filling and allowing the fill to remain in order to prevent further damage to the wetland, which could occur if it were removed, was reviewed by the Commission. Dana Rappaneau made a motion, seconded by Ed Breault, to have the Chairman sign the letter. Approved.

**Lake Winnecunnet**

Ed Breault gave the Director information from his files pertaining to the weed harvester. Ed Breault stated that the Winnecunnet Association paid to repair the weed harvester at their expense and now a trailer bill needs to be paid. Discussion ensued regarding whether the Conservation Commission or Town General Fund should be used to pay the bill. Ed Breault stated that approximately \$8,000 - \$10,000 has been put into the harvester and trailer, at the Association's expense. Leonard Silvia made a motion, seconded by Patrick Corcoran, to have the Conservation Commission pay \$1,075 to Aquatic Unlimited for the weed harvester trailer parts. The Commission plans to include the money in their account in future years for maintenance purposes.

Carlos Fragata stated that an Aquatic Control Technology representative would be going on-site to give an estimate on the cost of a potential management plan for the Lake.

Also the DEM was called re: grant money availability for aquatic weed control.

**Norton Reservoir**

Carlos Fragata stated that the Baystate Environmental Consultants, Inc. contract was signed by the Selectmen. Carlos Fragata also stated that Juniper Road and South Highland Road beaches were the best areas for a boat ramp, which could be put in by the Public Access Board.

Leonard Silvia made a motion, seconded by Dana Rappaneau, to authorize the Director to order office supplies needed up to an amount of \$50.00 if there was not enough time to present the supplies order before a regular Conservation Commission meeting. Approved.

Patrick Corcoran made a motion, seconded by Bob Medeiros, to adjourn the meeting at 8:30 pm. Approved.
