The members reviewed the draft minutes of August 10, 1998. Julian Kadish made a motion, seconded by Leonard Silvia, to table the minutes until the September 14, 1998 meeting. Approved.

The members reviewed a Request for a Determination of Applicability – **Peter Brennan – lot 7, assessors map 18, 4 Bartley Drive** – for proposed plans to construct a single family house, grading and associated utilities within the 100 foot buffer zone of a bordering vegetated wetland. Fred Bottomley represented the applicant. Dana Rappaneau made a motion, seconded by Julian Kadish, to close the public meeting. Approved. Dana Rappaneau made a motion, seconded by Julian Kadish, to issue a negative Determination of Applicability with conditions. Approved.

Approved.

The members reviewed a request for a full Certificate of Compliance filed by **John A. Sarnie, Jr. for bldrs. lot 34, p. 173, assessors map 14, 35 Laura Lane (DET. #600)**. Julian Kadish made a motion, seconded by Dana Rappaneau, to issue the Certificate of Compliance. Approved.

The members reviewed a request for a full Certificate of Compliance filed by **Hallsmith-Sysco Food Corp. for lot 18, parcel A-1, assessors map 32, 380 So. Worcester St. (#250-381)**. Dana Rappaneau made a motion, seconded by Leonard Silvia, to issue the Certificate of Compliance. Approved.
