

WETLAND HEARINGS

Abbreviated Notice of Resource Area Delineation – DEP# 250-994, Daniel Rich – 65 Plain Street (map 18, parcel 7) – for verification of wetland resource area boundaries.

Carlino apologized and explained the legal notice did not get sent to the Sun Chronicle. John DeLano presented the plan as an informal discussion. Wetland boundary was presented. The Certified Vernal Pool boundary is based on aerial photographs and not field delineated. Commission will make a finding that the VP boundary is not verified with the ORAD. The discussion and formal opening of the public hearing will take place on February 27, 2017.

Carlino apologized and explained the legal notice did not get sent to the Sun Chronicle. David Oberlander presented the plan as an informal discussion. Brief discussion was held about the No Disturbance Zone and visual barrier policy. Small pile of leaves to be removed from wetland and letter to be sent to owner explaining not to put leaves in wetland is all that will be required. The discussion and formal opening of the public hearing will take place on February 27, 2017.

Notice of Intent – (#250-995) – Erin Whoriskey, Massachusetts Electric Company d/b/a National Grid- West Hodges Street public roadway shoulder (nearest Assessor's Map 35, Parcel 7-04) –for proposed plans to install new underground conduit by directional drilling under wetland and Goose Branch Brook and within the 100-year floodplain.

The applicant requested a continuance to February 27, 2017. Motion was made by Carrozza, seconded by Pearson to continue to February 27, 2017. Approved.

Amended Order of Conditions - (#250-960) - Condyne Capital Partners - 60 Commerce Way, (Assessor's Map 24, Parcel 116)- (cont. from the October 24, 2016, Nov. 14, 2016 mtg, Nov. 28, 2016, Dec. 19, 2016, Jan 9, 2017, Jan 23, 2017.) - to amend/modify the building size, stormwater management and drainage changes, installation of fuel island and a new water line.

The applicant requested a continuance to February 27, 2017. Motion was made by Pearson, seconded by Franceschelli to continue to February 27, 2017. Approved. Carrozza abstained.

Notice of Intent (#250-983) — Muhammad Itani/Island Brook LLC — 0 East Main Street — (Assessor's Map 17, Parcels 57, 238, 239, 240, 241, 242, 243, 244 & 245) (cont. from the October 24, 2016, Nov. 14, 2016 mtg, Nov. 28, 2016, Dec. 19, 2016, Jan 9, 2017, Jan 23, 2017.)- for the construction of 56 single-family units with loop road, stormwater detention ponds and work within 200 feet of Rumford River.

The applicant requested a continuance to February 27, 2017. Motion was made by Carrozza, seconded by Pearson to continue to February 27, 2017. Approved.

Estimate received for final stabilization in spring. Motion was made by Carrozza, seconded by Franceschelli to issue Partial COC with bond of \$3,000.00 for final stabilization in Spring 2017. Approved.

(partial) Map 12, parcel 174 Lengthy discussion about the OOC requiring a culvert at the driveway and the driveway not being constructed according to plan or OOC. Letter received from Highway Dept stating culvert in driveway isn't needed; however, if there is a drainage problem, Highway will require owner to repair. No real method of ensuring this can be required. Discernible flow path for water now within driveway (site photographs). Discussion was held regarding final stabilization of the processed gravel driveway to

prevent sediment from leaving driveway and entering adjacent swales (road drainage) as well as prevent erosion of the driveway. Suggestion was made for adding 4-6" stone with filter fabric underlay to be added to low section of driveway to filter water and prevent erosion. Discussion of gutters causing erosion of driveway leading toward wetland. Discussion of site stabilization and reseeding in Spring 2017. Mr. Barron has occupancy or temporary occupancy. It was decided that Carlino would do site inspection with Barron as soon as snow melts and allows viewing of site stabilization and swales near Lincoln St. Motion was made by Carrozza, seconded by Pearson to postpone the decision

until February 27, 2017. Approved.

- Pare contract addendum request- Members asked if the run over budget was discussed prior to Pare Corporation going over. Carlino stated it was not. Members said the contract was for certain amount and had requirement that they notify us and modify contract if they will go over budget and since they didn't do this, the commission is not required to pay the overrun. This is not the first time we've had this discussion with Pare Corporation and commission finds this to be very unprofessional. It sends message that their project manager doesn't manage the billing correctly.
- Request for legal services to determine owner of all retaining walls- Carlino sent 2nd request to town counsel to determine ownership of retaining walls so we can modify our dam registration form, recorded at registry of deeds and determine our share of cost in repairing all walls. No response from counsel since request was made 2 weeks ago.
