Open meeting

The meeting was called to order at 6:34 pm.

A. 139 Pine Street compliance and ratification of Enforcement Order.

The property owners Lisa and Jeff Boyden were present. The Chair Ollerhead suggested that if there is a septic plan, the commission may be able to use that. Normally the edge of a wetland needs to be on the septic plan. So if they get a copy of that from the Board of Health, and it has the wetland indicated then they may be able to use this to indicate which trees they wish to take down as part of the NOI. The Boydens are planning to do the NOI application. They also have been in touch with a civil engineer and a wetland specialist. The Boydens were notified that December 4<sup>th</sup> was the deadline for the next meeting, which is December 18<sup>th</sup>.

Matt Ladewig of ESS and Colin Gosselin from Solitude presented an update on progress and recommendations for the waterbodies treatments. Town's four waterbodies are being treated for non-native, invasive aquatic plants. A new pioneer infestation of the invasive plant, swollen bladderwort, was found in three of the four ponds this year. Chartley Pond had more of an issue. Bladderwort is a cryptic plant when not in bloom and a species that they are watching. Fanwort was found for the first time in Chartley. These were weak. But they plan to get to these next year. This year had herbicide treatments in each of the four ponds. They varied depending on the targeted invasive plants. In this first year they achieved goals, knowing that this is a multi-year plan. This is a control program, and not an eradication program.

Matt started with Winnecunnet. He showed fanwort survey pre- and post-treatment. Treatment began in May with Sonar. Treatment was very effective. None was found post-treatment, however they don't expect it to be completely gone. They also treatment Variable Leaf Milfoil. Post treatment results showed greater open water, but still a band around the edge of the pond. They are now recommending another low dose of Sonar next year, to try and knock this Variable Leaf Milfoil (VLM) down. If Conservation Commission is ok with this, then they also need Natural Heritage approval for this second application. These are the two major species at that pond. Then he reviewed the Reservoir- also has Eurasian Milfoil, VLM, and Swollen bladderwort, and Fanwort. Sonar treatment in May with booster treatment had excellent impact in the Reservoir for VLM. Next year in the Reservoir they want to use a blend of contact herbicides in the areas where there were plants remaining post-treatment in year one. Chartley Pond- focus of treatment was Water Chestnut. Clearcast was used by applying directly to the leaves in three treatments. Beds were thinned out post-treatment. If you prevent this annual from making seeds, then in posttreatment you did not see seeds. VLM was there but they did not target this. In post-treatment it was reduced, but it may be seasonal, natural decline of the plants in the fall. This is a plant that will be targeted next year. Swollen bladderwort was not expected, low densities, but was throughout the pond. Barrowsville- Water Chestnut was targeted. It is almost entirely taken over by it. There are other invasives there, but they are kept at minimum due to the Water Chestnut. Densities were reduced, no seed set at the end of the season. VLM incidental in the pond. Could be locally dense. They were not targeted. Same with Fanwort. These may take off once Water Chestnut is controlled. Treatment was difficult due to the density of the beds. If they can get an airboat, they can get more efficient treatment. Water Bodies Committee was contacted. How can they get on into the pond- an alternative access point? Pearson asked what happens to the herbicides after the treatments? They have varying rates of decay into byproducts. Some are nondetected after as little as 48 hours.

Proposal to construct a new water treatment plant with associated water piping within 100 feet of a wetland.

A motion was made by Kadish, seconded by Pearson to issue Amended Order of Conditions as drafted, adding the amended conditions includes the limit of work shall be fenced with chain link or plastic jersey barriers prior to commencement of any earth moving activities. Approved.

E. Notice of Intent (#250-1001). Margaret Robinson, American Tower. 122 W Hodges Street (Map 34, Parcel 2) (cont. from 9/25/17, 10/16/17). Proposal for the construction of a 150-foot monopole communications tower within 100 feet of a wetland and rare species habitat.

Applicant requested a continuance. Motion was made to continue to 12/18/17 by Kadish, seconded by Pearson. Motion to Continue passes.

F. Notice of Intent (#250-100X.) Jeffrey O'Neil, Condyne Construct, 46 Commerce Way (Map 25, Parcel 86). Proposal to install approx. 1,100 linear feet of (2) 4" PVC conduits (in the same trench) in a proposed 20-foot-wide utility easement within 100 feet of a wetland.

Mark Dibb and Jeff O'Neil from Condyne Engineering was here to present the project. It is at the cul-de-sac of Commerce Way. The amendment reduces the project from 80,000 sq. foot building to a Ryder-only maintenance facility at the size of 20,860 sq. ft. All activity is within the previous limit of work. Now impervious roof area will be impervious paving. Stormwater design is the same. Minimal reduction in impervious surface at the site. He is waiting for review of some calculations from Commission Consultant J. Chessia at this time.

Carlino asked about the status of conditions 80, 81, & 82 and if they are compliance with existing permit. Dibb replied that the property has been cleared. There was an upland restoration area that has been completed. Dibb also responded to inquiry that yes the trees were planted every 10 feet on center, and shrubs every 8 feet on center as required and that the berms of the basins have been stabilized with mulch or grass. Currently the site is fully stabilized. The planting plan, and

reports still need to be sent to Carlino per the existing conditions, and Dibb said that he would send those. Chessia's comments will be in by the next meeting and all items are due from the applicant a minimum of one week prior to that meeting or the Commission will automatically continue to the first meeting in January.

Motion was made to continue the public hearing for 250-960 to 12/18/17 by Pearson, seconded by Blood. Motion passes.
