# WETLAND HEARINGS AND POSSIBLE COMMISSION DELIBERATIONS

Wetland hearings will be taken in order.

#### Chairperson to read about Public Hearings:

No in-person attendance of members of the public will be permitted, but the public can listen to/view this public hearing/meeting while in progress by <u>logging into the Zoom conference meeting listed at the END of this agenda</u>. Members of the public attending this public hearing/meeting virtually will be allowed to make comments if they wish to do so, during the portion of the hearing designated for public comment, <u>by raising their hand virtually or pressing \*9 if participating by phone</u>.

ConCom member Julian Kadish asked Carlino what the current situation is at Town Hall. Are employees and/or members of the public allowed to enter? Carlino responded that Town Hall is still open to employees only at this time. It is not open to the public yet. Kadish asked if there was any discussion as to when it would be open to the public. Carlino stated not to her knowledge.

A. DEP #250-988 - Amendment to Order of Conditions - Lukasz & Janice Wasiak - 183 Taunton Avenue, (Map 28, Parcel 151) - The proposed project is to amend an existing permit to construct an inground pool and patio with landscaping within 100 feet of wetlands and 200 feet of riverfront area. Craig Cyganowski of RIM Engineering and applicant Lukasz Wasiak attended the hearing. Cyganowski explained the first Order of Conditions was filed in 2016. There have been several changes over the years. He reviewed the current plans to explain the proposed changes. They are looking to remove the existing patio/deck and add a new porch/patio/deck area with inground pool. There is also a proposed storage area for pool and filter equipment on a concrete pad. There is an existing post and rail fence along the 25 foot buffer zone and floodplain area. Although that area is a floodplain area, Cyganowski states it has been lawn since 2016 when the project began.

Pearson questioned the previous violation of altering the floodplain area. Carlino responded the proposed plan is to restore the previous area as part of this permit.

Carlino questioned the buried propane tank. Is that allowed to be buried and what is the purpose? Wasiak responded that he is converting his heating system from oil to propane. His plumber said the size of his house and pool will require a larger tank that will be buried.

Kadish asked what the water table is there. Cyganowski stated it is in the area of the existing septic system. Kadish does not think you can put a buried propane tank near the water table. He just wanted to make them aware. Wasiak stated his landscaper may raise the tank once they excavate.

Carlino showed photos of the site. Carrozza asked if there is any additional tree clearing proposed. Cyganowski stated no. All work will be done within the lawn area.

Brian Dunn, Tracy Duarte and Justin of MBL Land Development & Permitting attended the hearing on behalf of the applicant.

Duarte reviewed the economic alternatives analysis. Duarte stated the only work within the Riverfront Area is for the basin. This is the only location suitable for the basin based on the test pits that were done throughout the site. She questioned the need for an additional or more detailed alternatives analysis. Carlino stated they must talk about the four items in the definition of practicable. Dunn reminded the ConCom the basin was moved to this location per the direction of the ConCom's peer reviewer. Carlino agreed. However, she stated it previously was not in a resource area and now it is. Therefore, the economic alternatives analysis needs to be done. The ConCom could have required a wildlife habitat evaluation. However, in exchange, Carlino stated they could provide detailed notes on how they would maintain the turtle nesting habitat that is left after the proposed project is constructed. She is just looking for a note on the plan with a sign designating the turtle nesting habitat area and how it will be maintained.

The applicant requested a continuance to 7/13/2020. Motion was made to continue the public hearing for DEP #250-1052 to July 13, 2020 by Carrozza, seconded by Kadish. Motion passes.

- 1. On the meeting date and time, turn to Norton Cable Station Channel 15 to simply watch the meeting.
- 2. To participate in the meeting, we recommend downloading the zoom app before the meeting. (This may not be necessary because you can click the link below but we have found that this makes logging in to the meeting easier.)
- 3. Join the Zoom Meeting at 6:30pm.

- The site can be a little tricky so if it doesn't work the first time, try again. Try copying and
  pasting the link into a google chrome browser if internet explorer or another browser
  doesn't work for you.
- Using "connecting to video and audio through the computer" has been the easiest method.
   So make sure your computer's video/audio is on.
- If you cannot hear, you may need to phone in by calling 1-646-558-8656, same meeting ID and password as above. If it asks for a participant id you can just hit #. Please put your phone on mute until the Chairman asks for your comments.
- Everyone will be placed on mute at the beginning of the meeting as you sign in but you should be able to hear. We will unmute you when we reach the public question and answer portion of our meeting.
- 4. If, for some reason, neither Zoom option is working for you, you can watch the cable station live feed and email the Conservation Commission at <a href="mailto:conservation@nortonmaus.com">conservation@nortonmaus.com</a> to ask your questions. We will read your email address, name and comments into the public record.
- 5. The standard procedure for a public hearing is a presentation by the applicant's representative; questions and comments by the Conservation Commission and Director; then opening questions and comments to the abutters. Please be patient and wait for your turn to participate.

6. If there are no additional questions by the Conservation Commission or Director, the hearing would typically close; however, to ensure adequate opportunity for public participation, those specific hearings will be continued until the next meeting. This will be announced. You will have until the next meeting to provide your comments and questions before the Commission closes the hearing and makes a decision.
