The meeting was called to order at 6:30pm.

WETLAND HEARINGS AND POSSIBLE COMMISSION DELIBERATIONS

Wetland hearings will be taken in order.

A. Notice of Intent (#250-1074) YMCA Attleboro/Norton, 295 West Main Street (Map 26, Parcel 292). The proposed project is to construct a camp pavilion, replace septic system and install water line utilities with associated tree clearing and grading within 100 feet of wetlands. Mark Mariano of Oakhill Engineering attended the hearing on behalf of the applicant in addition to CFO, Paul Fournier, of the YMCA.

Mariano explained the YMCA is looking to build a 60 x 100 foot one-season pavilion to provide the kids shelter in inclement weather. It would be built on a large paved area that was supposed to be a tennis court, but was never built. They would reduce their impervious footprint on the site as they build the structure and remove the remaining pavement. Restrooms would be added in the pavilion which would require infrastructure upgrades. They include a service line and septic system. Mariano showed the site and where the project would take place. It is approximately a 200-acre site. The pavilion would be in the center. The septic tank and pump chamber will be outside the 100-foot buffer. Most of the work for the utility upgrades would fall between the 50 to 100-foot area from the wetlands. The grading and tree clearing for the septic system would fall within the 50-foot buffer. This site was chosen after other test pits had poor material and high groundwater. The existing tree line will also allow the system to be somewhat visually shielded. The system itself will be partially raised due to the high groundwater. All of the work is less than one acre

Carlino questioned the detail for the culvert, earth bridge and post and rope fence. Mariano stated the detail is on page C4 of the more recent plans he submitted. He will submit a new page of the plan showing the posts on the edge of the clearing.

Motion was made to close the public hearing for DEP #250-1074 by Doyle, seconded by Blood. Motion passes.

B. Notice of Intent (#250-1075) Massachusetts Department of Transportation, Three Mile River Bridge MP 6.84 (Map 33, Parcel 11). The proposed project is to widen the existing track embankment/ballast and replace the existing bridge within 100 feet of bordering vegetated wetland and within 200 feet of the Three Mile River. Kyle Purdy and Tom Cabana of Jacobs Engineering attended the hearing on behalf of the applicant. Purdy explained the railroad embankment is located between Harvey Street and

New Taunton Ave. It will be crossing the Three Mile River. This is associated with the Attleboro secondary line. Pursuant to Section 24 of the Transportation Bond Bill, the bridge replacement work is exempt from the WPA. However, with their Notice of Intent, they have proposed widening of existing embankment or ballast of the railroad tracks for physical stability. They would like to widen the tracks and fill in gaps that have developed over time. There is a municipal line to the east, so they are also filing a Notice of Intent with Taunton. Next to the heightened embankment, there is BVW on both sides. The widening will take place within the 100-foot buffer zone to BVW and Bank as well as the Riverfront Area. There will be no impact to wetlands, waterbodies or the Bank. Purdy showed the impact areas on the plan. He gave detail of the bridge replacement being done through DEP to help the ConCom understand the purpose and need of the project. They would like to show these impacts of the track widening to DEP since that will require water quality certification. Permanent impacts total 5,365 sf within the 100-foot buffer zone and 634 sf within Riverfront Area. Carlino asked Purdy to revise page 3 of the NOI since that shows BVW being impacted. Purdy explained they are outside of BLSF. There was no flood impact study done for this segment of the Three Mile River. This is about 1 and ½ miles north of where the study was done. They calculated the elevation off of the 100-year storm event, All of their work is done above that elevation. Purdy stated their calculations have been done according to the Regulations. They are actually extending the bridge to get out of the impacts. Even though this segment is exempt from WPA, Carlino suggested they may want to show the elevation for the floodplain on the plan to show that they are actually outside of the floodplain. Purdy stated those calculations are also included in the Stormwater Report, but he will also provide the plans with the floodplain elevation detail.

Snyder noted the project is characterized as a limited project as a water-dependent use. What is the water dependent-use? Purdy explained the bridge replacement and the widening of the embankment/ballast is needed for stability of the replacement. Carlino provided a definition for water-dependent use showing how they qualify for that. Carlino then questioned the project being a limited project. Is it because they are above threshold in the Riverfront Area? Purdy stated it is also because it is a maintenance activity of an existing rail.

The applicant requested a continuance to 4/26/2021. Motion was made to continue the public hearing for DEP #250-1075 to April 26, 2021 by O'Reilly, seconded by Blood. Motion passes.

(continued from 9/14/2020, 10/19/2020, 11/9/2020, 11/23/2020, 12/14/2020, 1/11/2021, 2/8/2021, 2/22/2021, 3/8/2021, 3/22/2021) The proposed project is the construction of road and associated utilities within Riverfront Area and 100 feet of bordering vegetated wetland. Mark Dibb of Condyne Engineering attended the hearing. Since the last meeting, Dibb stated he responded to the Town's Consultant, John Chessia, and resubmitted a full set of plans. He has not heard back and believes they have met the review comments

Carlino stated she did receive a revised page 3 of the NOI. Carlino questioned the retaining wall that was discussed for the existing cart path during the site-walk. Dibb discussed the area on the plan and explained that he responded to Chessia's comments in January. Since this is already in the area of the cleared gravel driveway, they are requesting to maintain the grading as shown on the plan. They would not be disturbing any additional vegetation. There will be a double row of silt fence there during construction. A retaining wall would be costly, and they could only pull the limit of work in about 4 feet. The road was centered at the highest point possible. There is a retaining wall on the other side. This was summarized in his January 18th letter, and he did not receive any feedback. Doyle commented, after walking the site, he did not see any problem with keeping the existing grade and not doing a retaining wall. He asked if the post and rail fence would just go along the access road where the wetland is. Carlino replied it would be at the limit of work within resource areas.

G. Request for a Three-Year Extension on the Amended Order of Conditions (250-0978) Town of Norton, Mansfield Avenue/Norton Reservoir Aquatic Plant Management Program (Map 9, Parcels 229 and 230; Map 3, Parcel 733; Map 10, Parcel 525; Map 16, Parcel 65. The proposed project is to treat and remove aquatic invasive plant species using a variety of methods in the Norton Reservoir.

Matt Ladewig of ESS Group attended the hearing on behalf of the applicant. He stated ESS Group has been assisting the Town of Norton with managing the Norton Reservoir for the last few years. They have had much success controlling the invasive species there using a variety of methods. It is an ongoing challenge. He shared the results in the various ponds and reservoirs with each of the invasive species found. They are requesting a three-year extension to continue to implement this management program using the same tools approved by the ConCom.

Pearson asked if there are any fish species that would eat the invasive plants. Ladewig stated there are, but none are native to Massachusetts.

Doyle asked about the curly-leaf pondweed. It looks like it is increasing in the Reservoir, but there was no management action taken in 2018 or 2019. Ladewig explained they did treat Norton Reservoir during those years, but it was too late in the season to affect curly-leaf pondweed. That plant has a very short life cycle that starts early in the season. They are not specifically targeting the curly-leaf pondweed. It is difficult to treat and is only in the Reservoir for a short period of time. The Sonar application does affect it because it's done early in the year. They view it as an incidental plant that is being impacted by some of the treatments they do.

SIGN AND ISSUE ORDER OF CONDITIONS/ORDER OF RESOURCE AREA DELINEATION

REQUEST FOR PARTIAL/FULL CERTIFICATE OF COMPLIANCE

Full Certificate of Compliance DEP#250-0943 Town of Norton, Off Plain Street (Map 19, Parcels 2 & 3). The proposed plan is to construct a new water treatment plant with associated water piping within 100-year floodplain, Riverfront and within 100 feet of wetlands.

Tara McManus and Mel Higgins of Weston & Sampson attended the hearing on behalf of the applicant.

McManus reviewed the project and the three Conditions Carlino had questioned last week. She stated the work concerning Conservation was actually completed in 2018 and restoration of the disturbed areas is complete. The monthly reports referred to in Condition #36 were submitted in 2018. In 2019, grass seed was planted. In 2020, they checked to make sure the grass and disturbed areas were grown. They were waiting for As-Built plans from their contractor in order to request the Certificate of Compliance. Carlino had questioned Condition #44 stating the directional drilling should only occur during a period of low flow (July and August). McManus stated reports were submitted in August and September. In August, they identified that they would be into September before they completed the drilling work. Carlino also questioned Condition #64 stating all wetland resources areas would be kept clean of rubbish, debris and

construction materials. McManus stated that after the directional drilling was completed across the wetland area, everything was restored. There was no rubbish, debris or construction material left on site. Any material there now may be due to pedestrians that use that area as a cross route. Carlino asked about the Condition for pre and post photos. McManus stated post-construction photos were submitted. She will submit pre and post photos to show the work has not expanded beyond what the permit allows per Carlino's request.

Carlino will do a site inspection.
