D. Request for Determination of Applicability (DET #1109) Massachusetts Coastal Railroad, Massachusetts Coastal Railroad Right-of-Way. (continued from 4/12/2021, 4/26/2021, 5/10/2021, 5/24/2021) The proposed plan is to confirm wetland boundaries and approve vegetation management activities along the Ma Coastal Railroad Right of Way. Snyder explained that she and Blood did a site visit by the first marker on Sunday with Lewis. At the last meeting, Lewis had explained how they know where the wetlands delineation is, and how they know where to spray and where to stop. He explained how the truck applies the herbicide. Snyder stated it is low to the ground and sprays 10 feet in either direction from the center line of the track. They stop 10 feet before the marker and restart 10 feet after the marker. She stated the marker is easily seen so the herbicide should not be misapplied.

Blood noted the Right-of-Way is a difficult area to walk because of the ballast. If the ConCom does another site inspection, he suggests they make arrangements to use the use the car to travel the rail. He and Snyder only saw by the first marker up to the river abutment. The sprayer sounds like it is very accurate spraying the space between the rails and only 5 to 7 feet on either side. Blood was happy with the explanation of the process of the spraying of the herbicide.

Tom Lewis of TEC Associates attended the hearing on behalf of the applicant. He noted another town had similar concerns that this ConCom has expressed regarding the confirmation of the delineation line. There was concern someone could take a delineation for vegetation management and try to use it for other unrelated work. Rather than making a Determination to confirm the boundaries, they made the proposal to issue a Negative Determination only for the purposes of vegetation management. He wondered if this ConCom would consider something similar.

Carlino noted the Regulations do require him to have the boundary verified with the Determination, so she thinks it's important to keep that on there. Also, she had requested he revise the Determination request at the last meeting. His letter asks for the ConCom to make a decision

about the work as well. The first page of the request needs to be revised so the ConCom can give a Determination on the vegetation boundaries and the work.

The applicant requested a continuance to 6/28/2021. Motion was made to continue the public hearing for DET #1109 to June 28, 2021 by Pearson, seconded by Doyle. Motion passes.

# SIGN AND ISSUE ORDER OF CONDITIONS/ORDER OF RESOURCE AREA DELINEATION

#### REQUEST FOR AN EXTENSION

• Three-Year Extension (#250-1017) Dana Junior, 21 Samoset Street. (Map 25, Parcel 29). The proposed project is to construct a single-family house, driveway, utilities and associated grading within the 100-year floodplain.

Carlino explained the applicant has not responded to some questions that were sent out. It was agreed to table this discussion until the next meeting.

# REQUEST FOR PARTIAL/FULL CERTIFICATE OF COMPLIANCE

• Full Certificate of Compliance DEP#250-0625 Red Mill Village Trustees, Newland Street. The proposed project is to extend the sewer main on Newland Street within 100 feet of wetlands.

Carlino stated we have spoken to the Water Department, Planning and Highway. Nobody has As-Built plans. We were trying to assist Red Mill Village, but as the owners of the property, it is ultimately their responsibility to get As-Built plans. If they have an agreement or disagreement with the Water Department, it is between those two parties. Carlino has a phone call scheduled for tomorrow to review this with them. Carrozza asked if anyone had reached out to the contractor. Carrozza stated the proposed plans could possibly be used. Since the road is constrained by utilities, it limits where the sewer line could be installed. Carlino believes Red Mill Village has reached out to the contractor and had no response. Carrozza suggests reaching out to the contractor.

No action was taken.

• Full Certificate of Compliance DEP#250-0169 Attorney Robert Luciano, 19 Margaret Drive ONLY. The proposed project is to construct a residential subdivision, roadways, drainage, utilities, etc., portions of which are within bordering vegetated wetlands, banks, floodplains and within the 100-foot buffer zone of vegetated wetlands and banks associated with the Wading River.

Carlino explained this is an old subdivision. A Certificate of Compliance could be issued for this house lot only, but not for the whole subdivision. We do not have documentation that the road and stormwater management have been installed correctly.

Motion was made to issue a Full Certificate of Compliance for DEP #250-0169 for 19 Margaret Drive ONLY by Carrozza, seconded by Pearson. Motion passes.
