The meeting was called to order at 6:30pm.

Chairperson to read about Public Meetings:

Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Norton Conservation Commission will be conducted via remote participation to the greatest extent possible. Specific information and the general guidelines for remote participation by members of the public and/or parties with a right and/or requirement to attend this meeting can be found at the end of this agenda.

Members of the public attending this public hearing/meeting virtually will be allowed to make comments if they wish to do so, during the portion of the hearing designated for public comment, by raising their hand virtually or pressing *6 if participating by phone.

No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. Discussion: Jessie Knowlton, Wheaton College, Local pollinator conservation project proposal on conservation property

Jessie Knowlton, Wheaton College professor and Ecologist, and student, Erin Ortega attended the meeting to describe the proposal to conduct a preliminary survey of pollinator communities on conservation land and the relationship with the European (praying) mantis (Mantis religiosa) and the invasive Chinese mantis (Tenodera sinensis). Knowlton proposes a project with five of her students to:

- 1. Collect mantises, dissect them and sent their guts to a colleague at UC Riverside to use DNA barcoding to determine the mantis' diets.
- 2. Conduct bee surveys via transects, collection and identification of the bee and flowers they are pollinating.

The Commission asked where Knowlton and her students would conduct the study. Knowlton replied she has been to the Commission's webpage and looking at the listed properties. Carlino mentioned that it would be a great opportunity if the same students are still there in the Spring to enter the Massachusetts Association of Conservation Commissions' annual Environmental Conference poster contest. Carlino will send information to Knowlton. Carlino will also send Knowlton locations of two additional conservation properties.

Brad Fitzgerald attended the hearing and described the septic system replacement to the rear of the property in existing lawn. The homeowner will water the completed work for site stabilization. Kadish asked about the need for No Disturbance Zone markers. Carlino stated it would be beneficial to have 2-3 markers on 4 x 4 pressure treated posts.

A motion was made by Pearson, seconded by Blood, to close the public hearing. Roll call vote was taken.

Steve Balcewicz presented the project to the Commission. The owners would like to install an inground pool to an existing lawn within the previous limit of work. A 4' fencepost was mentioned. Carlino asked about topography. Carlino mentioned the previous permit required the No Disturbance Zone markers and hasn't been completed yet. They should also be working on their Certificate of Compliance from the previous project. Balcewicz will check with his colleague on the email sent from the Commission regarding this issue.

Balcewicz addressed the letter he received from the Director regarding plan changes. He will check to make sure he sent the PDF of the revised plan. Kadish asked if what remained on the project wasn't merely a matter of tying up loose ends.

Carrozza asked about equipment access. All equipment will come in from the existing driveway. Carrozza asked about the timing of site stabilization. Balcewicz said the work would be done this summer and would be stabilized in the Fall.

Pearson made a motion, seconded by Carrozza to continue the public hearing to July 26, 2021 for Balcewicz to confer with his colleagues regarding the plans and previous permit compliance. Roll call vote was taken.

Bruce Ringwall of GPR Inc presented the project to the Commission with James Basile, GPR and Jaime Smith, A/Z Corp in attendance. The College needs to televise their sporting events and will require upgrading their electrical system. An 18" conduit would be installed via trench digging along the edge of the existing field and would collect to the underside of the existing boardwalk over the intermittent stream. Carrozza asked if there was a detail for the connection to the bridge. There wasn't, answered Ringwall, because the intended part is just "basic hardware." He stated that the conduit would be installed by hand by someone beside or on top of the boardwalk, attached with basic hardware, and mounted to the underside of the bridge so as not to attract attention. Carrozza said with that provision, it was acceptable.

Kadish noted there was not a file number. A motion was made by Pearson, seconded by Blood to continue the public hearing to July 26, 2021 to obtain a DEP file number. Roll call vote was taken.

Carlino noted that the site inspection was done and that all work appears to be done according to the permit. She also noted that the previous violation in the 100-year floodplain appears to be corrected. The vegetation is growing without any additional mowing.

- 1. To participate in the meeting, we recommend downloading the zoom app before the meeting. (This may not be necessary because you can click the link below but we have found that this makes logging in to the meeting easier.)
- 2. Join the Zoom Meeting at 6:30pm. Using your computer or smart phone go the Zoom app and click "join a meeting" or click on:

- 5. The standard procedure for a public hearing is a presentation by the applicant's representative, questions and comments by the Conservation Commission and Director, then opening questions and comments to the abutters. Please be patient and wait for your turn to participate.

If there are no additional questions by the Conservation Commission or Director, the hearing would typically close; however, to ensure adequate opportunity for public participation, those specific hearings will be continued until the next meeting. This will be announced. You will have until the next meeting to provide your comments and questions before the Commission closes the hearing and makes a decision.
