 - i. Flyer to "at home" businesses Steve Hornsby said he might have funds for this during EDC's meeting with him. Renee will follow up with Mike Y. regarding the window decals that we could pass out to businesses when we start visiting them. Discussion around what would be beneficial to the town businesses versus those we are trying to attract to the Town. These would be two different take aways that would need to be developed. Could we use a Google Form to help us get organized? We could have a paper copy that also would be used as well as an online version that would feed the database. Renee will follow up about the funding we have and Kevin will work on a logo for the decals.
 - ii. Maggie continues to work on duplicates in the business database. She's been working on cleaning up the data since the last meeting. She also removed any expired licensed businesses.
 - iii. Once the database is updated fully, the Town will receive it and the NBA will also receive a copy. The Town will be the repository for the database and will be the "gatekeeper."
 - iv. The first phase of outreach would be 50 business that the EDC would visit in person with a few questions for discussion. Ideally along the Route 123 and 140 corridors. The EDC would aim for a Saturday and visit in teams of two or more for each visit. The





leave behinds will be a decal and an EDC business card with email address for future conversations and a QRC for questions/general business information.
