C. DeCosta reviews Board of Health recommendations and presentation.

Final estimate for capping \$2.5M Review of additional information:

Discussion on 25% contingency. P. Helmreich notes high figure. C. DeCosta feels the figure can be lowered but there is a chance

additional monies may be needed if unforeseen problems arise Liner proposed is #40 liner which has a fabric backing; originally proposed a #60 liner.

S. Lombard's proposal is for a #30 liner and 1 foot of cover.

C. DeCosta notes 1 foot can easily errode and $2\frac{1}{2}$ feet are needed. S. Lombard's proposal did not consider fencing and security. The Board of Health is also covering management fees, daily

control of site, in their proposal

R. Anderson questions maintenance of site.

C. Decosta notes unknown what maintenance covers and questions a 1 yr warranty.

S. Lombard's proposal is \$50,000 vs \$10,000 for erosion and sediment control.

The Board of Health does not feel the minimal requirements are enough to protect the Public Health. The Board of Health also did not pick the most expensive alternative

Discussion of fly ash and review of past problem. Vegetation includes grass seed, mix rye and quick (hydroseed) grass and fertilizer. \$37,800 for 22 acres.

S. Lombard states that his proposal should not compete with the Board of Health proposal. He felt that his job is to give the Town's people an alternative.
