S. Lombard notes he has narrowed to two people for the full time Town Accountant. Selectmen will appoint one on Thursday night.

Review of problems in accounting department. S. Lombard notes needs of the Town and of the Town Hall.

S. Lombard notes competition and additional knowledge of municipal government. One candidate has worked for two Towns as a Town Accountant.

The Personnel Board has reviewed both individuals and the salaries.

S. Lombard notes increase would be on appointment date and if the Finance Committee does not approve a transfer, a STM would be needed.

Review of past errors. P. Helmreich notes need of Town to employ experienced individuals and to keep them. Discussion of future decreases.

S. Lombard notes Town Accountant will be expected to attend Town meetings and some Finance Committee meetings.

P. Helmreich moves to recommend Finance Committee reserve transfer to Accounting Salaries by Chairman when appointment is made and not to exceed \$8,200.
