DOG OFFICER

Salary increased by 6.5%. The Dog Officer stated that she does not feel it is a fair salary. She noted her position of 30 hrs includes 24 hour coverage. She also performs animal control and has done it for 10 years. She also notes the Town's saving not needing a public kennel. She has spent \$6,000 updating her kennel.

The Dog Officer notes that she gets paid for keeping dogs for
10 days but she usually keeps many longer to try to find homes.
Mrs. Fogarty also notes time for court cases.

P. Helmreich questions increase in expenses. He requests actual expenditures for past 3 years.

Care and custody includes care of animals, \$5/day for 10 days.

Supplies includes dog food.

Review of licenses - the Town Clerk keeps track through department's

computer.

Mrs. Fogarty also notes need for Assistant. Cost of approx \$25 per week. She notes animal inspector would cover vacations and return calls. This would enable the job to be done right. The Dog Officer does receive sick time, vacation, but notes she needs to still take care of animals and answer phones.
