Personnel Board Chairman notes that the Board has set salaries and has proposed a few changes in salary ranges. Review of information presented.

P. Helmreich notes salary employee is not a 40 hour position and notes a salary employee is full time-perform a position's duties.

Chairman notes approx estimates in hours, 40 hours-full time,

30 hours-3/4 time, and 20 hours-1/2 time.

P. Helmreich notes that the Personnel Board has made comparisons with other communities and attempted to achieve equity internally but did not assess the financial difficulties of the Town. The Personnel Board Chairman notes that the Town cannot place the burden on the 30 employees and if anything is done to lower increases, it should be done across the board.

B. Nugent question lowering a contracted increase.

P. Helmreich notes Town contract that will be going into negotiations vs. contracts that have been settled and will

run their course.

B. Kimball notes that it is unfortunate that the two Committees do not settle contracts or have a say in the negotiations.

The Personnel Board tried to keep parity within Town and felt its responsibility was to the Town of Norton and its employees. Personnel Board members notes the right of an individual to act and negotiate with Town Manager on their own.
