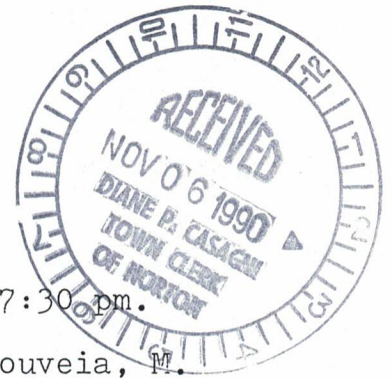


FINANCE COMMITTEE MEETING MINUTES

August 13, 1990



The meeting was called to order at approximately 7:30 pm.

PLANNING BOARD

The Planning Board notes that the Town Planner has joined the Middle Management union.

They are requesting a transfer from the Finance Committee reserve of \$66.60.

This would be to increase the Planner's salary 6% under the contract, an additional 1% than received, \$310.
