FINANCE COMMITTEE MEETING MINUTES April 3, 1991

- P. Helmreich informed the Committee that \$1,000 in the Selectmen's budget is payment to Computer Emporium for handling and processing parking tickets once they are written and not for printing parking tickets.
- P. Helmreich received a communication regarding the Agricultural County High School noting that \$700,000 of the \$2.7M budget for the School will be apportioned to cities and towns sending students to the school in proportion to the number of students enrolled. The assessment per student will be approximately \$2,700 and the Town of Norton will need to budget \$16,200 to cover the costs for the 6 Norton students enrolled. One half of the payment is due July 1st and the other half will be due on November 1st.
