FINANCE COMMITTEE MEETING MINUTES 6/1/92

Chair Hackett called the meeting to order at 7:45 p.m.

The Special Town Meeting Warrant will be discussed this evening.

W. Gouveia made a moton to oppose removing more expenditures than are already recommended, seconded by P. Zawasky. In favor: Unanimous.

The Special Town Warrant was then discussed, as follows:

A petitioner, came before the FinCom. After discussion, W. Gouveia moved to recommend Article 3, seconded by P. Helmreich. In favor: P. Helmreich, D. Ward, W. Gouveia, D. Summerfield. Opposed: M. Brown, P. Zawasky. Motion carried.

W. Gouveia moved to Recommend Article 1 with \$236,000 taken from the Stabilization fund providing that stabilization is not passed at regular town meeting, amended by P. Helmreich to wait until Article 5 is voted on & lost, seconded by D. Ward. In favor: Unanimous. Motion carried.

P. Helmreich moved that Article 2 be Recommended at \$4,500 to come from Stabiliation only if Article 5 has been voted and lost - if Article 5 has been voted on and passed, we will take no action, seconded by W. Gouveia. In favor: Unanimous. Motion carried.

A poll was then taken for Article 8:

Police - Addition of \$18,495. In favor: P. Zawasky, P. Helmreich. Opposed: D. Ward, M. Brown, D. Summerfield, W. Gouveia

Fire - Addition of \$28,824. In favor: none. Opposed: Unanimous.

Tree Warden - Addition of \$9,781. In favor: Unanimous.

FinCom Reserve - Add \$15,000. In favor: P. Helmreich, P. Zawasky. Against: D. Ward. W. Gouveia, D. Summerfield, M. Brown.

Library - Addition of \$55,092. In favor: D. Summerfield, P. Zawasky, P. Helmreich, D. Ward, M. Brown. Opposed W. Gouveia.

Recreation - Addition of \$11,430. In favor: P. Helmreich, D. Ward, P. Zawasky, W. Gouveia. Opposed: D. Summerfield, M. Brown.

Solid waste - Addition of \$5700. In favor: P. Helmreich, P. Zawasky, D. Summerfield, M. Hackett. Opposed: D. Ward, W. Gouveia, M. Brown.

D. Ward made a motion to adjourn, seconded by D. Summerfield. In favor: Unanimous. Motion carried.
