Some of the reasons for the increase in this year's budget are class size, opening of new school, and the addition of Social Studies, which were cut in earlier years. Over the next four or five years, there will an additional 400-500 new students. These figures do not include any new growth to the Town. These students are already here The School Department will hold a budget hearing some time in April.

The Norton Fire Dept. expressed some concern about the seminar cuts as well as cuts in overtime. George Burgess informed the Finance Committee that there is a possibility he might have to come back to the Committee to request additional funds.
