## NEW BUSINESS

### **Budget Items:**

Town Manager, McCabe talked about how rapidly personnel is growing overall. Contracts in some cases are higher than the cost of living. Our health insurance has had a double digit increase.

Police Dept.

Included in the salary figure is \$12,793 for an additional officer, provided we receive additional funding under the COPS grant. Police Chief Finch is looking to promote a patrolman from within and hire a replacement. Should the COPS grant not come through, Chief Finch will not fill the position and the \$12,793 will not be spent. Expenses include a 70% increase in ammunition, the purpose of which is to allow for more training. Equipment includes 10 new shotguns and bullet proof vests.

Fiore made a motion seconded by Nicolas to move \$150,964 for Account 570.

Vote: 4 in favor, 1 abstention (Desrochers); 4 opposed (Summerfield, Barrett, Thomas, Nicolas)
