Fiore made a motion seconded by Thomas to transfer \$12,000 from FinCom Reserve to Fire Department Repair & Maintenance Account for the purpose of paying cost to rebuild Engine No. 2. Vote: Unanimous

Helmreich made a motion seconded by Fiore to transfer \$1,000 from FinCom Reserve to Zoning Board of Appeals Clerical Services Account for the purpose of paying clerical worker to take minutes of ZBA meetings and process applications for variances from Zoning By-Laws. Vote: Unanimous


