School Department

Dr. DeMoura along with members of the School Committee were present to discuss School Department FY01 Budget. Budget figures are 10.46% higher than last year's budget. Some of the explanations given for the increase are as follows:

- 3 additional teachers at the LG Nourse School
- 5 additional teachers at the Yelle School
- 1 additional English teacher at the High School
- 1 full-time nurse at the LG Nourse School
- 1 half-time psychologist for Special Needs
- 2.5 additional teachers for Special Needs
- 5 Assistants for Special Needs
- I additional custodian staff person for the Yelle School
- Added an additional teacher at the High School during FY00
- Attendant Officer is putting more time
- Overtime of 8 hours per week has been added to the central office, due to the need for someone to be present at the school
 until all the buses have returned

Nicolas made a motion seconded by Fiore to move \$17,699,633. Vote: Unanimous

Warrant Articles

Article 15 - Athletic Complex

Discussion: Looking for \$58,000 to hire engineer to draw up a plan. Should take 4-5 years to complete. School Department will solicit private businesses for donations. Various fundraisers are planned.

Article 16 - Community School Project

Discussion: Nicolas suggested offering our space to outside agency. Dr. DeMoura would like to see the School Dept. more in control. We are in a tight fiscal year. Finance Committee is not recommending article at this time.

Nicolas made a motion seconded by Helmreich to recommend \$42,784. Vote: All opposed. Motion failed
