## ANNOUNCEMENTS

- Mike Thomas asked to have his strong opposition to the Finance Committee's vote not to fund additional positions in the Communications Department noted in the minutes of this meeting. He stated the Town Manager acknowledged the need for 3 additional positions in the next 3 years. Thomas feels the lack of staffing in that Department has an adverse impact on Public Safety.
- Chairman Barrett read a letter from the Norton School Dept. in which they stated they would like to take a "wait and see" position on the issue of an additional fourth grade teacher. At present, there are approximately 24 students in each homeroom. The School Dept. would like to wait for the enrollment figures before taking a position on this matter.

• Discussion: People don't want a railroad or a dump in their backyard (Fiore). Need money available to take swift action (Thomas). \$50,000 won't stop a train (Brown). There is a proposal pending to operate a landfill on the Norton/Attleboro line.
