#### **VOTING**

Article 4 Gouveia made a motion seconded by Fiore to recommend \$79,020.82 to be taken from Capital Improvements for the following expenditures:

Vote: Unanimous Motion Passes

#### Discussion:

- Doors at the Barrowsville Fire Station need to be raised in order to fit a vehicle inside the building
- Purchase of Taurus and Explorer will replace the Police Chief's vehicle, which currently has 130,000 miles on it and replace a Detective's vehicle, which now has 150,000 miles on it.
- Total cost for Communication's computers is \$59,650 consisting of \$10,00 for software; \$11,650 for servicing; and \$38,000 for engineering. There is currently \$46,188 in the budget for this expenditure, hence the need for an additional \$13,462.

# **DISCUSSION**

Article 28 Petition of A. Fillebrown, et al

- Committee members would like to hear from the Planning Board and the Building Inspector
- · Chief Finch wants to see Old Dean St. paved and open for use. Would not want to see road abandoned.
- · Public hearing would not be required since Petitioner wants Town to discontinue use of the road...not abandon it.
- If road cannot be closed, Mr. Fillebrown will sub-divide and sell property.

# School - Projected \$83,000,000 new school

- The new school could actually cost close to \$100,000,000 by the time the project is completed.
- The \$3.8 million slated to be voted on at the October Town Meeting will buy plans and design
- Need is not pressing at this time, but is something that should be considered for the future.
- Cannot be done without a debt exclusion override
- Town of Norton is at the 21/2 limit now
- There is no need to rush into getting put on the list this year
- Operating cost for the school needs to be addressed
- Townspeople need to be able to look at what the \$80 million will bring to the Town
