Charles Gabriel of the Planning Board was present to discuss zoning and street acceptance articles. The Planning Board voted to accept all streets.

Peter Paravalos, Chairman, Historic District Commission was present to discuss proposed restoration and rehabilitation of the Campbell House located at 217 West Main St. Deed research is complete. House is over 300 years old. Estimated cost is between \$200,000 and \$300,000. It is not known at this point what, if any, funds would be available in grants from the State. It would cost the Town approximately \$12,000 to research availability of funds from the State.

Jennifer Carlino, Conservation Agent, was present to discuss Lake Winnecunnet Study. The study will take approximately one year to complete. Proposals were submitted by four companies. Weeds present a dangerous situation....some are 17 feet in length. Mosquitoes are another serious issue. Residents of Lake Winnecunnet are receptive to chemical treatment of the weeds. Commission voted to complete this project ahead of the Reservoir Dam Project.
