# **Discussion of Annual Town Meeting Articles**

Various articles were discussed. Active/passive recreation sites discussed.

Mr. Purcell said criteria listed in Ms. Carlino's report would be helpful to FinCom and criteria to be spelled out in every parcel. Mr. Helmreich said it would be beneficial to know how much is wetlands and how much could be used for active recreation.
