Call to Order

Meeting was called to Order at 7:35 pm.

I. Approval of Minutes (done at end of meeting)

Motion was made by Ms. Desrochers to approve the May 12, 2008 Finance Committee minutes as written. Second by Mr. Graf. Vote: Unanimous. **Motion carries**.

Motion was made by Ms. Desrochers to approve the June 11, 2008 Finance Committee minutes as written. Second by Mr. Graf. Vote: All in favor, with Mr. Bouchard and Mr. Zawasky abstaining. **Motion carries**.

II. New Business

A. Transfers:

Mr. Purcell, providing a handout, reviewed the Massachusetts Municipal Finance Law that addresses transfer of appropriations (Chapter 44, Section 33B).

Mr. Purcell reviewed the Budget Transfer Recommendations. The total request for these transfers is \$26,100, with \$0 implications on FY '08.

Motion was made by Mr. Thomas to recommend the transfer of \$26,100, itemized as such:

Transfer of \$738.00 from Board of Health Dept. Expense (510-570) to B of H Overtime Salaries (510-510);

Transfer of \$4,478.00 from Gasoline Acct. (940-540) to Highway Expenses (420-570);

Transfer of \$6,000.00 from Fire Salaries (220-510) to Fire Expenses (220-570);

Transfer of \$12,246.00 from Police Expenses (210-570) to Police Salaries (210-510);

Transfer of \$385.00 from Unemployment (911-570) to Dog Officer Salaries (292-510);

Transfer of \$400.00 from Unemployment (911-570) to Dog Officer Expenses (292-570);

Transfer of \$1,459.00 from Veteran's Benefits (543-579) to Veteran's Salaries (543-510);

Transfer of \$394.00 from Gasoline Account (940-540) to Medicare Tax (910-570).

Second by Mr. Zawasky. Vote: Unanimous. Motion carries.

Mr. Purcell, providing a handout of Reserve Fund Transfers, stated that the balance in the Reserve Fund is \$37,783.83. He presented the FinCom with 2 Reserve Fund Transfer Requests.

Motion was made by Mr. Thomas to recommend the transfer of \$22,500.00 from the FinCom Reserve Fund to Legal Services (1-151-520-5300). Second by Mr. Zawasky. Vote: Unanimous. **Motion carries**.

Motion was made by Mr. Thomas to recommend the transfer of \$9,352.00 from the FinCom Reserve Fund to Street Lighting (1-425-520-5211). Second by Mr. Zawasky. Vote: Unanimous. **Motion carries**.

Other Business:

Mr. Tarantino requested that Mr. Purcell provide him with possible dates for a FinCom training day.

Mr. Purcell said that he would be recommending to the Selectmen that October 6th be the date for the Fall Town Meeting.

Bond Rating – Mr. Purcell said that the town's rating has gone up. He also said that states are requesting that towns be treated like the private sector.
