II. New Business

Mr. Purcell reviewed the Fall Town Meeting Warrant with the FinCom as follows:

Article 1 - Unpaid bills - there are 4 unpaid bills totaling of \$7,761.71. He said that they are not at the lease stage yet, but that the Selectmen recently voted to submit a letter of intent

Article 2 – Water Dept. Administrative Strategic Plan – the funding for this will come from the Water Surplus account.

Article 4 - Operating Budget supplements/transfers - a total of \$10,100 supplements, with \$9,800 of that going to the sanitary landfill project. Also, there are 2 transfers - \$100 for office supplies for Finance Committee use, and \$24,250 for Data Processing. Mr. Purcell explained that the present outsourcing of data processing is not working and that it needs full-time attention.

Article 7 - Governmental Accounting Standards Board Statement #45 - this is federally mandated.

Article 8 - Affordable Housing Nonprofit Corporation - Habitat For Humanity is seeking land parcels to build upon.

Article 9 - Salary Plan - Initially, Mr. Purcell stated that this article may be withdrawn and that he would like to look at the entire personnel by-law and update it. Upon further discussion, it was pointed out by Mr. Helmreich that if the article was dropped then the Information Technology Director position would not have an official salary range. It was also noted that this article should include the "Custodian - Police Station" position. Mr. Purcell suggested the possibility of either switching Article 9 & 10 or combining them.

Article 10 - Amendment of the "Job Classification" listing - this article may be combined with the previous article.

Article 11 - Wetlands Protection By-law - Ms. Jennifer Carlino, of the Conservation Commission, will address the FinCom concerning this article at the next meeting on Monday, September 21st.

Articles 12 & 13 - acceptance of public ways - Rubin Dr., a new road, and Beverly Lane, a 20+ year-old road.

Article 14 - Restaurant Meal Tax - Selectmen voted last week to remove this article from the warrant.
