



Finance Committee Meeting Minutes March 28, 2017

I. 7:00 P.M. Call to Order

The March 28, 2018, meeting of the Finance Committee was held in the Board of Selectman's Meeting Room and was called to order at 7:00 P.M., by Mr. Dorney, Chairman. Members Present: Mr. Michael Fiore, Mr. Richard Dorney, Mr. William Rotondi, Mr. Tom DeLuca, Mr. Paul Helmreich, Mr. Peter Carignan, Ms. Aimee Sawyer, Mr. Aaron Smith, Ms. Bonnie Yezukevich and. Also in attendance was Mr. Mike Yunits, Town Manager. Not in attendance: Mr. Walter Eykel and Mr. Stephen Evans.

II. Budget Discussions

Mr. Mark Morris, Business Manager of the Southeastern Regional High School, came before the Committee and presented the budget (Dept. 306) and discussed the schools continued growth and curriculum popularity. Some items of note include the FY19 Norton town assessment of \$1,047,296, which is an increase of \$50,906 (4.9% from FY18) and enrollment. Norton student enrollment is 91, which is an increase of 3 students from the prior school year. The Town of Norton represents 6% of total student enrollment. The FY19 Overall School District Budget is \$27,224,832, an increase of 3% from FY18.
