I. 6:10 P.M. Call to Order

The October 15, 2018, meeting of the Finance Committee was held in the Norton High School Cafeteria prior to Fall Town Meeting. II. Discussions

- a. Fall Town Meeting Article Review
 - i. Article 3 SE Regional Assessment

There are 4 additional students attending SE Regional, raising our annual assessment from \$75,000 to \$148,000

Motion was made by Mr. DeLuca to revote on Article 3. Seconded by Mr. Dorney. Vote 9-0 Motion Carries

Motion was made by Mr. DeLuca to Raise and Appropriate \$148,000 for the assessment to SE Regional Vocational Technical School. Seconded by Mr. Dorney. Vote (9-0) Motion Carries.

Motion was made by Mr. DeLuca to update total budget line item to \$775,122. Seconded by Mr. Dorney. Vote(9-0) Motion Carries

ii. Article 13 - Easments at Woodland Meadows

Some minor changes have been made on the previously approved easement design for the sewer installation at Woodland Meadows. The new plan will save a few trees, all other aspects of the article remain the same.

Motion was made by Mr. Fiore to revote on Article 13. Seconded by Mr. DeLuca. Vote 9-0 Motion Carries.

Motion to accept changes to the Easement Plan and recommend to town meeting was made by Mr. Fiore and Seconded by Mr. DeLuca. Vote 9-0 Motion Carries.
