C. School Department Update

The window and door project should be completed by January 22, 2020, contractor waiting on parts and has punch list items to complete. Masonry work will be completed in the spring. Claim for asbestos abatement is under negotiation.

D. Town Hall and Community Center Projects

M. Viveiros from DBVW presented their initial review of public, private, parcels currently for sale, and land owned by Wheaton College within the Study limits. These parcels were initially reviewed as to their size (2 to 3 +/- acres required to site one building & 5 +/- acres to site both buildings). M. Viverios reviewed each parcel's location, approximate size, cost, and suitability. There was general discussion and questions from the Committee and those present including wellhead protection areas, sewer project currently under construction and general knowledge of the various parcels. Several additional parcels within the Study limits were identified to be included in the Study.

O'Brien reviewed the schedule for the Study leading up to the May 18, 2020 Town Meeting. Goal of the Committee is to have the Study completed with options presented to the Selectboard such that public informational meetings can occur around mid-March 2020.

Town Meeting warrant articles will be due February 12, 2020, and a place holder will be included until the Town Manager and Committee draft the article pending the results of the Study and decision by the Selectboard.

E. Committee Membership

Brian Bechet was welcomed as a new member to the Committee.

F. Other Business

The OSHA Report regarding their inspection of the existing Town Hall is still not available. Committee suggested that an approximate cost to remedy the identified issues, retrofit or rehabilitate the existing Town Hall be prepared such that those costs can be shared with the public. The public needs to be aware that not building a new Town Hall will still cost the Town money to address the serious issues associated with the existing building.
