Building Envelope Study

The School Department is awarding the town-wide building energy audit project to Trane. Committee discussed the approval process, project scope, and which town-owned buildings are to be included in the audit. S. Cohen indicated it was for all town-owned buildings, but no list was immediately available, S. Cohen to obtain additional information on the project, its scope, procurement process, which buildings are included, and offered to have a member of the School Department attend a future meeting of the Committee to discuss the project further.

Committee expressed some concerns that the School Department's energy audit project is not a building envelope study, however it should provide some good information and provide a basis of a building envelope study.
