Student Representatives Update:

Chairman Savas recognized the teachers in attendance.

Opening of School Report – Mrs. Megan Lafayette:

Principal Lafayette introduced the new staff members in attendance. Enrollment as of October 20th is 746 students. Average class size is approximately 23. Some science classes and electives have higher numbers and additional staff in those areas would be beneficial. Sports teams are all doing well. The high school is in the process of creating a team to compete on High School Quiz Show on WGBH television.

Vote to Approve Music Field Trip to New Hampshire – Mr. Nick Krafka:

Norton music teacher Nick Krafka was present to request permission for the middle school band to travel to Canobie Lake Park in New Hampshire after attending the Great East Music Festival on May 29th, 2015. Tickets to the festival and the park are \$47 per student. Approximately 145 students and 14 chaperones are expected to attend. Several fundraisers are planned to help offset the costs.

The Committee was also asked to approve a second field trip for the high school to New York to see the Broadway play "Wicked". Approximately 70 students will attend, and the cost is \$219 for transportation, play tickets, and lunch. Fundraisers are also planned. Dr. Baeta recommended that the Committee approve both trips.
