Call to Order: The meeting was called to order at 6:30 PM.

Student Representative Update:

Student Representatives updated the Committee on current activities.

Vote on FY 2017 Budget:

Dr. Baeta said the proposed budget reflects the values and expectations of the district with students as a priority. Graduation rates are up and student drop-outs at its lowest. The district was recently rated as 87th in the entire state. Students leaving the district have decreased and the numbers for school choice and international students have increased. Meeting the goals set by the Committee will most likely require a Prop 2 ½ override now that the economy has somewhat recovered. There are no additional fees or increases. The Committee briefly discussed the budget and said it had been a decade without any significant increase.

ARTICLE: To see if the Town will raise and appropriate the sum of **\$TBD** to supplement the Fiscal Year 2017 operating budget for the Town and the Public Schools, as follows; provided, however, that the appropriation authorized hereunder shall be expressly contingent upon approval of the voters of the Town of a so-called Proposition 2 ½ override question pursuant to the provisions of M.G.L. c.59 § 21C.

The actual sum will be discussed further but the article had to be submitted as stated above to meet the February 3rd submission deadline.

Mr. Currle read an impressive list of accomplishment by the school sports teams. The boys and girls spring track teams made school history by both becoming state champions. The boys soccer team became the undefeated state champions. All the teams achieved many state, league, and school titles, and many athletes earned individual honors. Special congratulations to Coach Greene who was named Boston Globe boys soccer coach of the year.
