Call to Order: The meeting was called to order at 6:30 PM.

Pledge of Allegiance:

Mr. Savas congratulated Sheri Cohen and Kathleen Stern on their election and welcomed them to the Norton School Committee.

Dr. Baeta, acting as Chairman pro tem, opened nominations for the position of chairman. Mr. Sheedy nominated Mr. Savas, who accepted. Mrs. Cohen seconded the nomination. FY '17 Budget Update – Dr. Baeta:

Dr. Baeta stated that the first of the scheduled community forums was held and questions are coming in. He has put information on the website. The vote on the override is May 17th, and if it is voted down, significant discussions on the next steps will take place. The "pay to play" option was discussed. Dr. Baeta stated that this option, along with others, is based solely on what has the least impact on the classroom. There are no changes to Chapter 70 funds. Dr. Baeta also mentioned that three questions will appear on the November state ballot concerning Common Core, marijuana legalization, and charter school limits. The NEASC evaluation at the high school is in progress and going well. The cost to the school department is \$25,000 from its current budget.
