School Choice 2014 - 2018 - Dr. Baeta:

The school choice enrollment has increased each year since it was implemented. Dr. Baeta reviewed the school choice statistics for 2014-2018 as follows:

June 2015 (13); June 2016 (41); June 2017 (55); and March 2018 (90)

The tuition from school choice over the last four years has totaled \$1,087,009. Dr. Baeta reviewed the different ways the district advertises for new students. Many districts in the surrounding area are now offering school choice.

Athletic Boosters Information - Dr. Baeta:

Dr. Baeta discussed the results of the survey recently done by the booster groups. Future organization, fundraising, scholarships, and future spending were discussed.
