Vote to Approve Girl Scout Project at JCS - Dr. Baeta:

Dr. Baeta received a letter from Samantha Ward, the daughter of a staff member, who is working on a Gold Award for Girl Scouts. She has recently completed an internship with READS Collaborative at JCS. She feels that if mainstream classes had easier access to learning American Sign Language they would be able to use those skills to communicate with READS

students. She is proposing a sign with the ASL alphabet to be installed at the JCS playground to encourage integration between the deaf/hard of hearing students and mainstream students at JCS.

Kindergarten Age Requirement - Mr. and Mrs. Geoff Raby:

Mr. and Mrs. Raby contacted Dr. Baeta to request addressing the School Committee regarding their daughter who turns 5 one day after the required cut-off day for entrance to Kindergarten. The current policy states that children who turn 5 on or before August 31 will be eligible to enter Kindergarten in September. The Committee and Administrators discussed this request and offered a new proposal. Children who will be 5 years old between August 31st and the first day of school, at the request of the parents, would be screened by the staff. Their decision is final. After this year the deadline for requests will be June 1st. Dr. Baeta said they would have to publicize the change for this year, extending the cut off date to early July.

Proposed Policy statement:

Students that are born after August 31st but before the first day of school for Norton Public Schools may be screened, at the request of their parent, to determine their readiness for Kindergarten. In order to be considered for early admission, parents must request a screening from the Office of Teaching and Learning no later than June 1st. The screening team will make a recommendation and that recommendation will be final. The Committee will officially update Policy JEB.

 Tech Language - Parents who wish to prevent their children from being photographed, interviewed or recorded should notify Norton High School in writing by October 1, 2018.

- Elevator Language Prohibits students from using the elevator without written permission from staff. Disciplinary action will result in unauthorized use.
- Smoking and Tobacco Use Redefines smoking and tobacco use to include smokeless tobacco/vaping, and e-cigarettes and consequences for use in the school building and grounds.

Vote to Approve Chapter 70 Funding Formula Resolution - Dr. Baeta:

Resolution Calling for Full Funding of the Foundation Budget Review Commission's Recommendations

Whereas the Massachusetts Foundation Budget Review Commission identified two areas (employee health insurance and special education) where the Massachusetts Foundation Budget significantly understates the true cost of educating students in the Commonwealth and has failed to keep pace with rising costs;

Whereas this underfunding means the cost of providing a quality education has increasingly been borne by local communities, most often at the expense of other vital municipal operations;

Whereas investing in education today leads to higher incomes, and thus investment in police, prisons, subsidized health care, low income housing, welfare, etc. in the future;

Whereas state and local economies are most effectively strengthened "by investing in education and increasing the number of well-educated workers."

Therefore Be It Resolved that the **Norton School of Committee of Norton**, **MA** calls on the Massachusetts Legislature and the Governor of Massachusetts to fully fund and adopt the recommendation of the Foundation Budget Review Commission in the immediate future.
