Informational update on DEP letter and agreement concerning wastewater treatment plant at NMS was discussed. Please see enclosed. Options were presented and the third option was accepted by the committee:

14B. By June 30, 2020: Collect average daily water meter readings from the NMS for the 2019-2020 School Year, and determine if a Title V variance pursuant to 310 CMR 15.416 is applicable. If a variance can be sought, convert the NMS Wastewater Treatment Plant to a Title V System in strict conformance with 310 CMR 15.000.

Dr. Baeta identified he signed the contract. He also sent a thank you to the engineers for the update and copied Town Manager Mike Yunitz, Board of Selectman, Director of Facilities Wade Lizotte and will contact the Water Superintendent.
