Opening of School Report Norton Middle School - Mr. Vincent Hayward

Mr. Hayward announced the Middle School had a successful opening of school with 608 students and 80 staff members. There are many clubs and activities for the students with two new pilot clubs: Global and Virtual Reality and a Russian club. The Drama club will be presenting Footloose this year. The Winter Concert was held 1/8/2020. The girls' soccer team had another undefeated season.

Positive Behavioral Interventions and Support (PBIS) is conducted in the Middle School. Lancer Lead has been provided with new tools to continue and he thanked the staff and administration. The Middle School is very proud to be a part of New England League of Middle Schools Spotlight. The Middle School is up for renewal and currently there are only six Spotlight Schools in Mass.

Vote to Approve Capital Improvement Plan - Mr. Matthew Wells:

Mr. Wells reviewed the 5 Year Capital Plan FY2021-FY2025. At the Spring 2020 Town Meeting the school will be requesting a total of \$354,000 for capital improvement. Dr. Baeta also addressed that we are coordinating with the police department for lights at the elementary schools. This is not shown on the plan.
